

Motion was made by Mr. Hedgecock, that Mr. E E LOWREY be and he is hereby appointed Road Supervisor within and for West End of Dawson Township, Tulsa County, Oklahoma. Motion was duly seconded by Mr. North and declared carried.

Motion was made by Mr. North, seconded by Mr. Hedgecock, that Bond of TOM R JOHNSON be and the same is hereby approved. Carried.

In the matter of the application of the Oklahoma Power Company for an order permitting them to construct a system of pole lines for the purpose of transmitting electricity, the following order was made:

#### O R D E R

This matter coming on to be heard this 19th. day of July 1926, before the Board of County Commissioners of said County and State, on the petition of the Oklahoma Power Company, a corporation, duly organized and existing under the laws of the State of Oklahoma, and it appeared to the Board that it is just and proper that the said Oklahoma Power Company, its successors and assigns, should be permitted to use and occupy the highways of said County for the purpose set forth in said petition, the consent of the Board is hereby given for such use and occupation of the following highways:

Between Sections 2 and 11, 11 and 14, 14 and 23, Township 16, North, Range 12 East; between Sections 2, Township 16 North, Range 12 East and Section 35, Township 17 North, Range 12 East; between Sections 2 and 11, 11 and 14, 14 and 23, 23 and 26 and 35, Township 17 North, Range 12 East, between Section 2 Township 17 North, Range 12 East and Section 35 Township 18 North, Range 12 East; between Section 2 and 11, 11 and 14, 14 and 23, 23 and 26, 26 and 35, Township ;8, North Range 12 East; between Section 2, Township 18 North, Range 12 East, and Section 35 Township 19 North, Range 12 East and between Sections 23 and 26, 26 and 35, Township 19 North, Range 12 East.

Said right of way to include the right to maintain the necessary stubs and guy wires and to trim trees where necessary proper clearance.

The consent, however, being subject to the following rules and regulations: That said Oklahoma Power Company shall place and maintain its poles upon, along, across such highways, under the supervision and subect to the rules and regulations of the Board of County Commissioners not less than twenty five (25) feet from the center of the highway, and shall maintain a clearance above the surface at all crossings of not less than twenty (20) feet, and shall remove at its own expense and all trees or obstructions that might interfere with said pole line, and shall at all times keep said line in good repair, and hold the county and citizens thereof, harmless from any and all damages caused by the construction and maintenance of said line.
