It was moved by Mr. Bridges, seconded by Mr. Miller, that the erroneous assessment affidavit filed by the City of Tulsa, Oklahoma, alleging the erroneous assessment of the N $\frac{1}{2}$ SE $\frac{1}{4}$ of Sec. 10-20N-13E, Tulsa County, Oklahoma, for the years 1909, 1910, 1911, 1912, 1913, 1914, 1915 and 1920, on the ground that said property, during said years, was owned by the original fullblood Cherokee allottee, be granted; and that the County Clerk issue a certificate of error on said property for the years mentioned. On roll call, the motion was unanimously carried.
