Pursuant to recess heretofore taken, The Board of County Commissioners reconvened at the hour of 3:00 o'clock P.M., with all members present: John H. Miller, Chairman, J. B. Gray and H. E. Bridges, Members. Andy Stokes, County Clerk.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that W. R. Odom be and he is hereby appointed Constable in Red Fork Township, District 14, Tulsa County, Oklahoma. All voting in the affirmative, motion was by the Chairman declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the County Attorney be, and he is hereby requested to furnish an opinion as to vacating certain restrictions on Wilshire sub-division in Tulsa County. All voting in the affirmative, motion was by the Chairman declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the quarterly report of T. E. Harris, Justice of the Peace of Sand Springs Township, Tulsa County, for the third quarter of the year of 1933, beginning on the first day of July and ending on the 31st day of September, 1933, in criminal cases, be accepted and filed. All voting in the affirmative, motion was by the Chairman, declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the quarterly reports of E. H.
