Gentlemen:

Because of the extra amount of work, of an emergency nature, and otherwise, we have found it necessary to be done because of the climatic conditions this season, and work that will naturally come in the next few months, which is usually the heavier part of our work, we find that certain appropriations are not adequate to keep and maintain our Township roads in the proper condition. In other cases, the appropriations as made and approved by the Board will not be needed, or will likely not be used, in view of other and more urgent work to be done.

I am, therefore, asking that the following transfers be made from the appropriations heretofore approved, in the accounts and amounts as set out below in order that we may draw upon the same for current operations.

Some of the work in the townships is really being hindered now because of inadequate funds, and many bills are being held by us in certain of the townships for work already performed; and, I am further asking if it will be possible, at this time to make certain book transfers, and draw against the same for work now being done, and for bills unpaid.
