

WHEREAS, Osage County has designated the Delaware Creek Valley Highway which runs West from a point on the Osage-Tulsa County Line southwest of Sperry as Osage County Highway No. 28, and

WHEREAS, it is deemed to the best interest of Tulsa County to designate a County Highway to meet the above described highway.

NOW, THEREFORE, BE IT RESOLVED, THAT "The Section line running E & W between fractional sections 14 and 28, T 21 N., R 12 E., adistance of 2,915.2 feet to the Osage-Tulsa County Line; thence South 690.35 feet along the Osage-Tulsa County Line",

be and is hereby designated a Tulsa County Highway, to be known as Mile 5a of Section "D".

The vote on the motion to adopt the resolution being unanimously in the affirmative, the motion was declared carried.
