Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock A.M., with the following members present: J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk. John H. Miller, Chairman, absent.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that J. B. Gray act as Chairman of the Board of County Commissioners in the absence of John H. Miller, Chairman. Upon roll call, the following vote was taken: Gray, Yes; Hopkins, Yes. Motion carried.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the affidavit of erroneous assessment filed by Anna E. Moore, covering realestate for the years 1929 to 1932, inc., be and the same is hereby approved and the County Clerk is directed to issue a certificate of error covering same, mp provided, however, that the certificate of error shall not be issued until the expiration of twenty days from the date of this order and, provided further, that said certificate of error shall not be issued if any protest be filed within said twenty days until the issue of said protest is determined. Upon roll call, the following vote was taken: Gray, Yes; Hopkins, Yes. Motion carried. Miscl. No. 37376.

The following resolution was introduced and on motion duly made and seconded same was unanimously passed adopting resolution determining assessments in Water Improvement District No. 9 of Tulsa County, Oklahoma. The vote had was: Gray, Aye; Hopkins, Aye.

## ASSESSMENT RESOLUTION

WHEREAS, this Board of County Commissioners of Tulsa County, Oklahoma, did appoint a time for holding a session to hear and consider any complaints or objections concerning the appraisement and apportionment of the costs of construction of the public distribution system in Water Improvement District No. 9 of Tulsa County, Oklahoma, and the proposed assessments therefor and caused due notice of such session to be published according to law and in pursuance of such action and publication such session has been duly convened and held by this Board of County Commissioners on the 25th day of April, 1938, at ten o'clock A.M., in the County Commission Room in the County Courthouse in Tulsa, Tulsa County, Oklahoma; and

WHEREAS, the Board of County Commissioners has heard and considered all complaints and objections to said appraisements and apportionment and levied the same; and

WHEREAS, all legal requirements have been duly complied with to authorize the levy and assessment to pay the cost of said improvement: and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, that there shall be and there is hereby levied and assessed against the several tracts, lots and parcels of land in said Water Improvement District as benefited the amounts respectively stated in the report of the Board of Appraisers and which is levied and confirmed as follows:
