WHEREAS, at the meeting of the State Highway Commission in Oklahoma City on
December 19, 1928, it was agreed that Tulsa County should proceed with the preparation of
detailed plans and specifications for a reinforced concrete arch bridge over the Arkansas
River near Sand Springs, and that the State Highway Department shall prepare alternative
plans and specifications for a steel truss bridge; and

WHEREAS, the Board of County Commissioners, under date of October 22, 1928,
entered into an agreement with Victor H Cochrane, Eugene N Wood and Donald Witten to do
certain preliminary work, which has been completed, and to prepare final working plans and
specifications for the said reinforced concrete bridge;

are hereby authorized and instructed to proceed at once with the preparation of detailed
plans, specifications and estimates for a reinforced concrete arch bridge in accordance
with the terms of, and in consideration of the fee stipulated in, the said Agreement of
October 22, 1928.
