

and whereas, from the plans and estimates prepared for the purpose and submitted to the board of County Commissioners, it appears that the cost of constructing a courthouse and purchasing the necessary site therefor will be \$200,000, and

Whereas, said county has no jail adequate for the needs of said county, and an urgent need exists for the construction of a jail in and for said county, and

Whereas, from plans and estimates prepared for the purpose and submitted to the board of County Commissioners in and for said county, it appears that the cost of the construction of a jail and the purchase of the necessary site therefor would be \$25,000, and

Whereas, at an election duly petitioned for and called and held in all respects in full compliance with law in said county, on the 19th day of October, 1909, more than three-fifths of the qualified voters of said county, voting thereat, voted in favor of the issuance of the negotiable coupon bonds of the county of Tulsa for the purpose aforesaid and to the amounts aforesaid. Whereas, in order to raise sufficient funds for the construction of said courthouse and jail and for the purchase of necessary sites therefor, it is deemed and hereby declared necessary that said county borrow money to the amounts and for the purposes aforesaid, and to issue its negotiable coupon bonds therefor. Now, Therefore, Be It Resolved And Ordered, by the board of County Commissioners of the County of Tulsa of the State of Oklahoma:

That for the purposes mentioned in the preamble hereof,

there shall be and there are hereby ordered and directed to be issued, the negotiable coupon bonds of the county of Tulsa, of the State of Oklahoma, as follows:

That for the purpose of providing the necessary funds for the construction of a courthouse and the purchase of the necessary site therefor at the county seat, in and for said county, there shall be and there are hereby ordered and directed to be issued the negotiable coupon bonds of the said county of Tulsa, of the State of Oklahoma, to the aggregate amount of 200,000; said bonds shall be designated court house bonds 1909, shall be 200 in number, numbered from 1 to 200, both inclusive, of the denomination of \$1000 each.

That for the purpose of providing the necessary funds for the construction of a jail and the purchase of the necessary site therefor at the county seat in and for said county, there shall be and there are hereby ordered and directed to be issued the negotiable coupon bonds of the said county of Tulsa, of the State of Oklahoma, to the aggregate amount of \$25,000; said bonds shall be designated jail bonds of 1909, shall be 30 in number, numbered 1 to 30, both inclusive, and shall be of the following denominations, to wit: bonds numbered 1 to 30 both inclusive shall be of the denomination of \$1,000 each except that bonds numbered 3, 6, 9, 12, 15, 18, 21, 24, 27 & 30 shall be of the denomination of \$500 each.

That each and all of said bonds above ordered and directed to be issued shall bear date as of the 1st day of December, A.D. 1909, and bear interest from their date at the rate of five per centum per annum, payable semi-annually on the 1st days of June and December in each year, which installment of interest to date of maturity
