


Motion made by Commissioner Bailey, seconded by Commissioner Caffey that the Cash Fund Estimate of Needs and Request for Appropriation for the T-UNRESTRICTED CASH FUND in the amount of \$46,467.12; And for the 2-T Restricted Cash Fund in the amount of \$7,801.97; And for the 4-T Restricted Cash Fund in the amount of \$8,148.11, be approved. Upon roll call, motion carried.

Motion made by Commissioner Caffey, seconded by Commissioner Bailey that the motion made in the meeting of the Tulsa County Board of County Commissioners, February 26, 1951, to vacate 12th Street from the west side of the Northeast Quarter (NE $\frac{1}{4}$) of Section Eleven (11), Township Nineteen (19) Range fourteen (14), East between Blocks One (1) and Two (2) and Four (4) and Five (5) of Lynn Lane Estates, a distance of One Thousand Three Hundred Eighty-Five (1,385) Feet, be rescinded and 12th Street be left as now dedicated.
