MONDAY, JULY 31, 1986

The Board of County Commissioners for Tulsa County, Oklahoma met at the hour of 9:30 a.m. with the following members present: John Selph, Chairman; Melvin C. Rice, Member; Lewis Harris, Member; and Marie Smith, Deputy County Clerk.

John Selph, Chairman, presiding, the meeting was called to order at 9:35 a.m. and the following business was transacted:

Moved by Rice, seconded by Selph, on behalf of Fiscal Officer, to approve acceptance of claims, negotiate payments and release of damages from the involved parties (Patricia A. Hyams and Chad Hyams) in the accident with Officer Patrick Owens, Tulsa County Sheriff's Office. Upon roll call, Rice, yes; Harris, abstained; Selph, yes. Motion declared carried. (Clerk's Misc.
