Motion made by Commissioner Bailey, seconded by Commissioner Greer, that the following Order Creating Sewer Improvement District No. 1, Tulsa County, Oklahoma be, and hereby is approved:

ORDER CREATING SEWER IMPROVEMENT DISTRICT NO. 1
TULSA COUNTY, OKLAHOMA

NOW on this 2nd day of June, 1947, the Board of County Commissioners of Tulsa County, Oklahoma, being in regular session, with all the members of said Board of County Commissioners and the County Clerk of said County being present, there comes on for hearing the petition of Edward Fleischnich and others, filed with the County Clerk of Tulsa County, Oklahoma, on the 19th day of May, 1947, asking for the creation of Sewer Improvement District No. 1, Tulsa County, Oklahoma, described in said petition.

Thereupon there was presented to said Board of County Commissioners proof that notice of this hearing upon the aforesaid petition would be had on this date at the hour of 10:00 o'clock a. m., and that said notice was given by publication thereon in The Tulsa Daily Legal News, a newspaper printed and of general circulation in said County of Tulsa, State of Oklahoma, on May 19, 20, 21, 22, 23, 24, 26, 27, 28, 29, 30 and 31, 1947, and which times of publication were for a period of at least two full weeks before the date of this hearing as required by law, and said Board of County Commissioners, being fully advised in the premises, finds that due and legal notice of this hearing upon the aforesaid petition upon this date has been given as provided by law, and the said Board of County Commissioners further finds that no person has appeared to object to said petition, and that no person has filed in the office of the County Clerk of said County any written remonstrance or objection whatsoever against the creation of Sewer Improvement District No. 1, Tulsa County, Oklahoma, and improvements proposed by or as located by said petition, and that there are no objections to the creation of said Sewer Improvement District No. 1, Tulsa County, Oklahoma, for the Board to hear or determine.

The Board of County Commissioners of Tulsa County, Oklahoma, further finds that the creation of Sewer Improvement District No. 1, Tulsa County, Oklahoma, proposed by or as located by said petition, will be conducive and beneficial to the public health and will promote the public peace, health and safety in the district, and will be a public utility and benefit.
