IT IS THEREFORE ORDERED by said Board of County Commissioners that the lands delineated or shown on the map attached to the petition, and now under consideration by said Board, showing the boundaries of said district, and being all the lands situated in Third Crestview Estates, Tulsa County, Oklahoma, according to the recorded plat thereof, be and they are hereby constituted a sewer improvement district, and shall hereafter be known and designated Sewer Improvement District No. 1, Tulsa County, Oklahoma, subject to the result of an election to be held in said district on the 24th day of June, 1947, for the purpose of determining whether or not said Sewer Improvement District shall be created and organized, which election shall be conducted in accordance with the general election laws of the State after said Board shall have given due notice of such election and describing therein the boundaries of the district as established, the name of such proposed district, and which notice shall be published for at least three weeks prior to said election in The Tulsa Daily Legal News. Such notice shall require the electors to cast ballots which contain the words: "Sewer Improvement District No. 1, Tulsa County, Oklahoma Yes" or "Sewer Improvement District No. 1, Tulsa County, Oklahoma Yes" or "Sewer Improvement District No. 1, Tulsa County, Oklahoma No". Return of such election and the canvassing of the ballots shall be as provided in such notice.

Under and by virtue of the Constitution of the State of Oklahoma, and the statutes of the State of Oklahoma, and particularly under Section 2 of Senate Bill No. 127, enacted by the regular session of the Twenty-first Legislature of the State of Oklahoma and approved on April 16, 1947, authorizing and directing the undersigned Board of County Commissioners of Tulsa County, Oklahoma, to call a Special Election for the purposes hereinafter set forth: We, the undersigned Board of County Commissioners of Tulsa County, Oklahoma, hereby call a special election to be held in the voting precinct for Third Crestview Estates, located at 1305 South Memorial Drive, Tulsa County, Oklahoma, according to the recorded plat thereof, on Tuesday, June 24, 1947 for the purpose of submitting to the qualified tax-paying voters of said Third Crestview Estates, Tulsa County, Oklahoma, the following proposition:
