Recyclers, Inc. as sole source for disposal of waste oil, solvents and chemicals. The following schedule of fees will be held firm for a one year period beginning July 20, 1987:

1. \$.20/gal. for disposal of waste oil with less than 20% bottom sediment and water content.
2. \$.40/gal. for disposal of waste oil with more than 20% bottom sediment and water content.
3. \$55./drum for disposal of waste solvents and chemicals with low chloride content.
4. \$75./drum for disposal of waste solvents and chemicals with high chloride content.
5. \$100./drum plus transportation charge for disposal of mixed waste with high solids content that have to be sent to Lone Mountain site.
6. \$150./drum evaluation charge on waste material that cannot be tested by Hydrocarbon Recyclers but have to be sent to the Lone Mountain Facility for evaluation.
