(If the voter desires to vote for the proposition he (she) shall stamp an "X" in the first square above; if the voter desires to vote against the above proposition he (she) shall stamp an "X" in the second square above.)

The voting place is in Lynn Lane Precinct No. 5, located at 1305 South Memorial Drive, Tulsa, County, Oklahoma, and the persons who shall conduct such election shall be as follows:
