## RESOLUTION

WHEREAS, the Nineteenth Legislature of the State of Oklahoma enacted House Bill No. 97 relating to Fairs and Expositions in counties of 100,000 to 200,000 population, and therein provided:

"That in any county of this state coming within the provisions of Section 1 hereof, the Board of County Commissioners may, at its option, and by a resolution entered of record in the Commissioners Journal of proceedings, disclose its intention to avail such county of the provisions and terms of this Act, and within thirty days thereafter such board of County Commissioners shall meet for the purpose of placing in force and effect the provisions hereof."

AND, WHEREAS, it is the desire and intention of the Board of County Commissioners of Tulsa County, Oklahoma, to avail said County of the provisions and terms of said Act, (House Bill No. 97) of the Nineteenth Legislature of the State of Oklahoma; 1943 Session Laws (Harlow's) page XXX 17;

NOW, THEREFORE, BE IT RESOLVED that this resolution be entered of record in the Commissioners' Journal and proceedings as an expression of its intention to avail said County of the provisions of said Fair and Exposition Act, House Bill No. 97, 1943 Legislature, (Harlow's Session Laws, page 17), and that within thirty days hereafter the Board of County Commissioners of Tulsa County, Oklahoma, shall meet for the purpose of placing in force and effect the provisions of said Act.
