RESOLUTION

WHEREAS, Tulsa County owns a 1935 Chevrolet Truck, 1-1/2 Ton, Serial Number 9QB06-6152, Motor Number 4719492, and

WHEREAS, said Chevrolet Truck being in a state of bad repair and not generally serviceable for the uses and purposes of the Highway Department, to which said Chevrolet Truck belongs, and was purchased and paid for from County Highway Funds, and

WHEREAS, the Highway Department is in need of a Truck, and has found that a trade or exchange can be made with R-K Motors, Inc. for a Ford Truck, 1947 Model, Motor Number 99T1661409, in exchange for the Chevrolet Truck, with a further consideration of payment by Tulsa County to R-K Motors, Inc. the sum of Two Thousand, One Hundred Fifty Dollars & No/100 (\$2150.00).

NOW, THEREFORE BE IT RESOLVED, That the Chairman of the Board of County Commissioners be authorized to transfer title to the aforesaid Chevrolet Truck, and deliver same to R-K Motors, Inc. in exchange for the Ford Truck when accompanied by a proper transfer of title to Tulsa County, and that the County Highway Department be authorized to draw a Claim to the R-K Motors, Inc. in the sum of Two Thousand, One Hundred Fifty Dollars & No/100 (\$2150.00), payable from Account Number 6B, designated as "Highway Equipment" of the County Highway Department GENERAL Fund.
