ORDER

NOW, on this the 18th. day of August, 1926, the matter of the petition of the Oklahoma Natural Gas Company for permission to lay a pipe line along, under and across certain highways in said County and State came up before the Board of County Commissioners of said County for hearings and it appearing to the Board and each of the Commissioners thereof that it was just that the said Oklahoma Natural Gas Company be permitted to use as much of the highways as designated by plat filed by said Company and according to said description, which is as follows; to-wit:
