RESOLUTION

WHEREAS, there has been established a Federal Aid Secondary Road System for the County of Tulsa, State of Oklahoma, and approved by Federal Works Agency, Public Roads Administration, and the State Highway Commission:

AND WHEREAS, it is deemed desirable now that the system heretofore established be enlarged and added to.

NOW, THEREFORE, be it resolved that the Department of Highways of the State of Oklahoma, is hereby requested to revise the Seconday System heretofore established, by adding the following roads. to-wit:

Along the North Section line from the Northwest corner of Section 19, to the Northeast corner of Section 21, Township 21 North, Range 13 East, laying between Sections 16, 17 and 18 on the North and Sections 19, 20 and 21 on the South for a distance of three (3) mimcs from Federal Aid Route No. 25 east to Federal Aid Secondary Route No. 7212.

REASONS

This Highway east of Bird Creek is now a School Bus Route. The Mail Route will come back onto the Highway as soon as the Sperry Spybuck Bridge over Bird Creek, is completed. Improvement of this road will connect up the community of Sperry with a more direct route to Owasso and Collinsville.
