

MARCH 26, 1951

The Board of County Commissioners of Tulsa County reconvened Monday, March 26, 1951 at 10:00 o'clock a. m., with the following members present: J. W. Hardesty, Chairman; William V. Caffey, Member; Claude W. Bailey, Member. William P. Gable, Jr., County Clerk.

J. W. Hardesty, Chairman, presiding, the following business was transacted.

Motion made by Commissioner Bailey, seconded by Commissioner Caffey that the Cash Fund Estimate of Needs and Request for Appropriation for the County Highway T-UNRESTRICTED CASH FUND in the amount of \$49,238.85; And for the County Highway 2-T RESTRICTED CASH FUND in the amount of \$7,474.20; And for the County Highway 4-T RESTRICTED CASH FUND in the amount of \$8,172.23, be approved.
