It is moved by Mr.North, and motion was seconded by Mr.Hedgecock, that the County Clerk be and he is hereby directed to prepare a financial statement of the General Fund for the current year as of January 31st. 1929, together with an application for additional appropriation for current expenses for the remainder of the ensuing fiscal year and submit the same to this Board.

The report of Hal Turner, Court Clerk for the month ending December 31st. 1928 is received and ordered filed.

Nothing further to come before the meeting, same is herey ordered adjourned until Monday, January 28th. 1929, at 9 o'clock A M.
