of said twelve months shall resume the payment of rentals, in the same amount and in the same manner as hereinbefore provided. And it is agreed that upon the resumption of the payment of rentals as above provided, that the last preceding paragraph hereof governing the payment of rentals and the effect thereof, shall continue in force just as though there hasbeen no interruption in the rental payments, and if the lessee shall commence to drill a well within the term of this lease or anyeextension thereof, the lessee shall have the right to drill such well to completion with reasonable diligence and dispatch, and if oil or gas, or either of them be found in paying quantities, this lease shall continue and be in force with like effect as if such well had been completed within the term of years first mentioned.

If said lessor owns a less interest in the above described land than the entire and undivided fee simple estate therein, then the royalties and rentals herein provided for shall be paid the said lessor only in the proportion which lessor's interest bears to the whole and undivided fee.

Lessee shall have the right to use, free of cost, gas oil and water produced on said land for lesseess operations thereon, except water from the wells of lessor.

When requested by lessor, lessee shall bury lessee's pipe lines below plow depth.

No well shall be drilled nearer than 200 feet to the houseor barn now on said premises without written consent of lessor.

Lessee shall pay for damages caused by lessee's operations to growing crops on saidland.

Lessee shall have the right at any time to remove all machinery and fixtures placed on said premises, including the right to draw and remove casing.

assigning in whole or in part is expressly allowed, the covenants hereof shall extand to their heirs, executors, administrators, successors or assigns, but no change in the owner ship of the land or assignments of rental or royalties shall be binding on the lessee until after the lessee has been furnished with a written transfer or assignment or a true copy thereof; and it is hereby agreed that in the event this lease shall be assigned as to a part or parts of the abive described lands and the assigneeeor assignees of such part or parts shall fail or make default in the payment of the proportionate part of the rents due from him or them, such default shall not pperate to defeat or affect this lease in so far as it covers a part or parts of said lands upon which the said lessee or any assignee thereof shall make due payment of said rental, and this lease shall never be forfeited for non-payment of any rental due until after at least ten days written notice by registered mail or in person shall have been given the lessee.

Lessor hereby warrants and agrees todefend the title to the lands herein described, and agrees that the lessee shall have the right at any time to redeem for lessor bypayment, any mortgages, taxes or other liens on the above described lands, in the event of default of payment by bessor, and be subrogated to the rights of the holder thereof, and the undersigned lessors, for themselves and their heirs, successors and assigns, hereby surrender and release all right of dower and homestead in the premises described herein, insofar as the said right of dower and homestead may in any way affect the purposes for which this lease is made, as herein recibed.

If a test well is not commenced on said land within ninety days from date hereof and completed to a sufficient depth to test the Turkey Mountain Sand at approximate ly 2100 feet deep, unless oil or gas is found in paying quantities at a lesser depth, this lease shall become null and void.
