O R D E R

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to ALICE HENDRIX of a deed conveying to her for a consideration of TWENTY AND NO/100 DOLLARS (\$20.00) the following described lots:

Lots 13 - 14 - 15 - 16 Blk 3, Middleton Taylor Add. to Collinsville.
