

Upon the instruction of the Chairman, the following sealed Bids submitted by the Standard Paving Company covering Project No. 2-C Extension to Shell Creek Bridge a distance of 0.2102 miles; in the amount of \$4,112.60; Project No. Levee Approaches 2-E a distance of 0.1096 miles in the amount of \$2,153.10; Project No. 2-M Approaches over Levee, South of Jenks a distance of 0.1837 miles in the amount of \$3,657.30, together with their bid check in the amount of \$500.00. Motion was made by Commissioner Couch, seconded by Commissioner Evans, and unanimously carried, that these bids be referred to the County Engineer for his compilation and report.

Motion made by Commissioner Couch, seconded by Commissioner Evans, and unanimously carried, that upon the recommendation of the County Engineer, the alleys in Blocks 8 and 9 of New Taneha Addition, being a part of Section 32, Township 19 North, Range 12 East, be vacated.

Motion made by Commissioner Couch, seconded by Commissioner Evans, that the two reports filed by the County Clerk for the months of February and March, 1949, be and the same are hereby accepted and filed. Motion unanimously carried.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the following Resolution be, and the same is hereby adopted, and the Chairman is authorized to sign same, to-wit:

RESOLUTION

WHEREAS, the City of Tulsa has employed Sanitary Engineer, James P. Slater, to supervise the Sanitation Department of the City Health Department, and has invited the County of Tulsa to bring its County Health personnel into closer cooperation with the City of Tulsa Health program and has suggested that the County Health Personnel, including nurses, sanitarians and Clerk share offices with the City Health Department at 521 North Boulder; and

WHEREAS, it appears desirable that Tulsa County make full use of the proffered services of James P. Slater, and that the health program of the City and County be coordinated;

NOW, THEREFORE, BE IT RESOLVED that the invitation of the City of Tulsa hereinable referred to, be, and the same is hereby accepted and the County Health Personnel are hereby directed to take all measures necessary to bring about a closer coordination of City and County Health programs, it being understood that in so doing Tulsa County, or its Board of County Commissioners, delegates no authority, assumes no additional financial obligations and enters into no contractual obligations, except as may hereafter be specifically authorized or undertaken by this Board; it being further understood that this resolution does not apply to the County Physician, the County Clinic or the County Welfare.

All Commissioners voting in the affirmative, motion is carried and resolution adopted this 4th day of April 1949.
