MONDAY, DECEMBER 15th, 1941.

The Board of County Commissioners met in regular session on Monday, December 15th, 1941, at the hour of 10:00 o'clock A.M., with all members present: J. B. Gray, Chairman; Ralsa F. Morley and Curtis Greer, members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

The following Resolution was introduced by Commissioner Greer, who moved its adoption; said motion being seconded by Commissioner Gray. Chairman ordered the resolution read.

R E S O L U T I O N

WHEREAS, on the 24th day of March, 1941, the Board of County Commissioners of Tulsa County, Oklahoma, acting upon the report of viewers duly appointed by the Board of County Commissioners of Tulsa County, Oklahoma, for the purpose of creating a levy and drainage district to be designated as the Tulsa-Sand Springs Levy and Drainage District, found that such a district should be created, and on said date by proper resolution by the Board of County Commissioners of Tulsa County, Oklahoma, such district was created and given the name of Tulsa-Sand Springs Levy and Drainage District, Tulsa County Drainage District Number 11; and the Board at that time found that said levy and drainage District is of private and public necessity and benefit, and is conducive to public health, sanitation, etc. The Board of County Commissioners at that time deferred the request to the District Judge of Tulsa County, for the appointment of three viewers as provided by Section 13010, Oklahoma Statutes 1931, and

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, now deem it advisable to ask the District Judge of Tulsa County, Oklahoma, to appoint three viewers as provided by Section 13010, Oklahoma Statutes, 1931;

THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Tulsa County, Oklahoma, that this resolution, and the resolution of the Board of County Commissioners of March 24, 1941, be certified to the District Judge of Tulsa County, Oklahoma, and that the District Judge is hereby requested to appoint three disinterested freeholders from the regular jury list of names prepared for the District Court, ~~for~~ who shall not be interested in the construction of said work and not kin to any person interested thereon, to act as viewers of the Tulsa-Sand Springs Levy and Drainage District, Tulsa County Drainage District Number 11, as required by law.
