NOW, THEREFORE, be it resolved by the Board of County Commissioners of Tulsa County, Oklahoma, that GLEN T. COLEMAN be and he is hereby appointed Clerk of Water Improvement District No. 8 of Tulsa County, and as a member of the Board of Directors of said District he is given such authority as has been previously given to the Clerk of said Board.

Upon roll call, all voting in the affirmative, motion was declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the erroneous assessment of the GRANITE SAVINGS BANK & TRUST COMPANY be denied for the reason that the Board of County Commissioners is without jurisdiction to hear and determine said application. Upon roll call, all voting in the affirmative, motion was by the Chairman declared carried.

Motion was made by Commissioner Miller, seconded by Commissioner Bridges, that no drugs be bought at the hospital and poor farm without the approval of the County Physician, and no patient to be admitted to or discharged from the hospital without the approval of the County Physician, and that the County Physician be instructed to call at least once a week to the hospital and poor farm and as many times thereafter as called by the nurse. All voting in the affirmative, motion was declared carried.

Letters were sent to Mr. Homer Bloomer, Superintendent of the County Farm, and Mrs. Alpha Huff, Nurse at the County Hospital, instructing them that no drugs should be bought without the approval of the County Physician, Dr. T. E. Roberts.

Motion was made by Commissioner Gray that the County Physician be instructed to take care of the obstetric cases in the homes. Motion died for the want of a second.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the telephones, as per list filed under the name of the Southwestern Bell Telephone Co., and the Board of County Commissioners, be discontinued, and a copy of instructions be mailed to the Southwestern Bell Telephone Company. Motion carried.
