PROPOSAL FOR THE PURCHASE OF BIRD CREEK BRIDGE
on MILE 8,SECTION "B", TULSA COUNTY HIGHWAY.

Hon.County Commissioners,
Tulsa County,Oklahoma.

Gentlemen:
The undersigned hereby submits the hereinafter offer for the purchase of the main steel span and steel span approach of the Old Bird Creek Bridge immediately east of Skiatook on original Mile 8 of Section "B" Tulsa County Highway; agreeing to tear down the same, remove all of the said steel span and steel span approach and remove any and all falsework that may be used, clearing the stream of the same, the wooden approaches to the said bridge to remain the property of Tulsa County and not to be dismantled by Tulsa County until after we remove the steel span and steel span approach;; the said steel span and steel span approach we hereby propose to buy in its present condition and according to the restrictions set out above, but agrees to not remove the same before August1st. 1927, unless permission is granted by Tulsa County to remove the same before such time and as a consideration in payment for the same, agrees to pay the full sum of Fifteen Hundred (\$1500.00) Dollars to be paid in the following manner, to-wit:

One Half ($\frac{1}{2}$) of the purchase price to be paid upon the acceptance of this proposal and the signing of a Bill of Sale by Tulsa County and the remaining One Half ($\frac{1}{2}$) of the purchase price to be paid before the said bridge material is removed from the site of the bridge, or if mutually agreed by Tulsa County and the herein bidder, as follows:
