Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 O'clock A. M. with the following members present: J. B. Gray, Chairman; Curtis Greer, Member. William P. Gable, Jr., County Clerk. Claude W. Bailey, Member, absent.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the following Resolution be and hereby is adopted. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried:

R E S O L U T I O N

NOW on this 27 day of June, 1947 there comes on for hearing before the board of County Commissioners, Tulsa County, State of Oklahoma a petition of Elmer W. Adams, County Attorney of Tulsa County Oklahoma, which petition prays for authorization of this Board to compromise and settle the case of the State of Oklahoma Ex rel Elmer W. Adams, County Attorney of Tulsa County Oklahoma, Plaintiff vs Roy Earl O'Hara, et al being case number 75486 District Court of Tulsa County Oklahoma and the Board of County Commissioners being fully advised in the premises finds

That heretofore on February 21, 1947 the above styled case was filed in the District Court of Tulsa County Oklahoma upon a Bond forfeiture of Roy Earl O'Hara, said bond forfeiture being in case number 12765 District Court of Tulsa County Oklahoma, in which case the defendant, Roy Earl O'Hara, was charged with the crime of Burglary,

The Board further finds that suit has heretofore been filed as above stated for the principal sum of \$500.00, Interest and court costs, that the sureties Mary Jane Smith has offered to compromise said action for the sum of \$333.33, being a sum equal to two-thirds of the principal sum, the Board further finds that said compromise offered is fair, just and equitable and should be authorized and accepted.

It is therefore resolved by the Board of County Commissioners of Tulsa County, Oklahoma that Elmer W. Adams, County Attorney of Tulsa County, Oklahoma is hereby authorized by the Board of County Commissioners of Tulsa County, Oklahoma to accept in full settlement of case number 75486 District Court, Tulsa County, Oklahoma the sum of \$333.33 and to dismiss said cause of action. The County Attorney of Tulsa County, Oklahoma is further authorized upon the receipt of said sum of \$333.33 to pay the sum of \$250.00 to the clerk of the District Court, Tulsa County, Oklahoma and to retain for his own use and benefit twenty-five per cent of \$333.33 or \$83.33 as is provided by Law.
