RESOLUTION AUTHORIZING CREATION OF A LEVEE AND DRAINAGE DISTRICT, TO BE NAMED AND NUMBERED, TULSA COUNTY DRAINAGE DISTRICT NUMBER 11.

At a meeting of the Board of County Commissioners, of Tulsa County, State of Oklahoma, held on the 7th day of October, 1940, there came before the said Board, the matter of a Petition signed by five or more residents of Tulsa County to claim to be affected and who would be assessed for construction, proposing the creation of a levee and drainage district; which petition described the nature of the improvements proposed and the approximate area by description of the territory proposed to be embraced in a levee and drainage district for the protection of said area as proposed against floor; the area proposed, being the Tulsa-Sand Springs region, comprising lands and improvements located in Sections 3-4-5-5-7-3-9 and 11, Township 19 North, Range 12 East; and, in Sections 1-2-3-10-11-12-13-14 and 15, Township 19 North, Range 11 East, as tentatively described in the said petition, which description is subject to amendment and correction, subject to the detailed survey proposed to be made, and, as by the engineer and viewers, later to be determined, and

WHEREAS, the petition having been duly examined by the Board of County Commissioners, having found the same sufficient and having found that the lands proposed to be embraced within the proposed district will be benefited by such drainage or improvements will benefit the health, will be of public utility and benefit.

IT IS RESOLVED: In accordance with the Prayer of the Petitioners contained in a Petition filed with the Board of County Commissioners of Tulsa County, State of Oklahoma, on the 7th day of October, 1940, petitioning the creation of a levee and drainage district, affecting lands and improvements in the area described as above set out, the said petition is hereby approved and said proposed district shall be named and numbered, "TULSA COUNTY DRAINAGE DISTRICT NUMBER ELEVEN".
