Now on this 8th day of March, 1910, this matter coming on for hearing before the Board of County Commissioners of Tulsa County, Oklahoma, upon the application of the petitioners for said drainage district for an order nunc pro tunc to correct and complete the records of the County Clerk of this County relative to said drainage districts, and it having been made to appear that upon the 10th day of August, 1909, that this Board of County Commissioners did approve and ratify contracts made by R. K. Hughes for and on behalf of this Board of County Commissioners for the construction of certain sections and parts of the drains within said drainage district with C. G. White, M. J. Albright, J. H. Shellenberger and J. J. Shrimp, respectively, which said contracts are on file and are hereby referred to and made a part hereof, and said contracts having been signed by the said parties and their approval and ratification endorsed thereon by W. L. North as Chairman of this Board, and C. F. Rogers as Clerk; It is therefor considered, ordered, adjudged and decreed that the contracts entered into as above set forth by said R. K. Hughes Engineer, for the Board of County Commissioners and the said several parties as contractors, be and the same are hereby approved, ratified and confirmed and that this order as of the said date, the said 10th day of August, 1909.

In The Matter of Formation of Drainage District Upon Petition of C. G. White, J. H. Shellenberger et al.

Order Nunc Pro Tunc.

This matter coming on to be heard on the 8th day of March, 1910, by the Board of County Commissioners of Tulsa County, Oklahoma, there being present in open Court the petitioners of Frey Drainage District No. 1, in said Tulsa County, upon their application for an order nunc pro tunc herein correcting the order made by this Board on the 18th day of January, 1909.

The Board having heard the evidence and examined the pleadings and being fully advised in the premises, and being satisfied that a clerical error has been made in said order of January 18, 1909, in that part of said order describing the boundaries of said drainage district in which it is set out that said lands are described as follows:

Beginning at the Northwest Corner of Section Twenty-Two (22) in Township Eighteen (18) North, Range Thirteen (13) East; thence running south something over three miles to where the section line intersects the left bank of the Arkansas River; thence down said river along the left bank to where said river crosses the range line between Ranges Thirteen (13) and Fourteen (14) East; thence North along said Range line to a point where said Range line crosses the Township line between Townships Seventeen (17) and Eighteen (18); thence East one-half mile to the middle of the south boundary of section Thirty One (31), Township Eighteen (18), Range Fourteen (14) East.
