Bids on work on Avery Hill

The bids on the road work as advertised, between sections 25 & 30, and 31 & 36 Township 20, North, Ranges 13 and 14 East, were opened, and the list showed as follows:

C.C. Sigler bid 47 cents per cubic yard, for fill and 32 cents for cut, flat rate.

Kelley Gibson, bid 15 cents per cubic yard, for all dirt work, for fills and cuts, and 33 cents for loose rock and 65 cents for solid rock, and $2\frac{1}{2}$ cents for all finished work.
