MONDAY, JUNE 11, 1945

Pursuant to recess heretofore taken, the Board of County Commissioners of Tulsa County, reconvened at the hour of 10:00 o'clock A. M., with all members present: Curtis Greer, Chairman; J. B. Gray and Robert L. Kinkaid, Members. Andy Stokes, County Clerk.

Curtis Greer, Chairman presiding, the following business was transacted.

Motion made by Commissioner Kinkaid, seconded by Commissioner Gray, to amend the motion made on June 4th, 1945, by Commissioner Greer and seconded by Commissioner Gray, to purchase 15,000 bbls. of tank bottoms at Fifty (50¢) cents per bbl., to increase the purchase to 20,000 bbls. of tank bottoms at Fifty (50¢) cents per bbl. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Kinkaid, seconded by Commissioner Gray, that the appointment of William Shue, as Blade Operator, at \$8.00 per day, effective June 11, 1945, and the appointment of J. F. Dorrell, as Truck Driver, at \$8.00 per day, effective June 6, 1945, County Highway Department District No. 3, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Kinkaid, that the appointment of Charles E. Guynn, Truck Driver, County Highway Department District No. 2, at \$180.00 per month, effective May 7, 1945, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Kinkaid, that Claim #367207 filed by Russell King, amounting to \$87.50 and filed May 29th, 1945, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Kinkaid, seconded by Commissioner Gray, that the appointment of Henrietta M. Covington, Deputy Court Clerk, at a salary of \$170.00 per month, effective June 1, 1945, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the following affidavits of erroneous assessments filed and approved by Dan A. Rowe, County assessor, be and the same are hereby approved and the County Clerk is hereby instructed to issue certificates of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried. To-wit:
