A Public Hearing, for the purpose of receiving comments from the public on the formation and creation of Criminal Justice District in Tulsa County, Oklahoma was called to order at 9:47 a.m. Selph asked if anyone present wished to speak and proceeded to read letter from Representative Grover Campbell stating his opposition, claiming parts of H.B. 1682 are unconstitutional and advising he has requested an Attorney General's opinion. Judy Simmons, Frenchie Loving, Rosemary Tarr, Reverend Lawrence Lakey and L. B. Smith spoke in opposition. Stanley Glanz stated they needed to look at current facilities and see if other solutions may be more effective. Rice stated he did not author the
