A motion was made by F. M. Wooden and seconded by Ira Short that the Warranty Deed made by Mary J. Bickford and John H. Bickford, her husband to Tulsa County, Oklahoma, for highway purposes by and the same is hereby accepted. Motion carried.

A motion was made by F. M. Wooden and seconded by Ira Short that W. P. Hall be allowed on his affidavit of erroneous assessment a reduction of \$1000.00. Motion prevailed.

A motion was made by George E. Gilmore and seconded by F. M. Wooden that the resignation of Bert Frye as Constable within and for District No. 11, Sand Springs, be and the same is hereby accepted, and be it further moved that Jack Naud be appointed to fill the vacancy caused by the resignation of Bert Frye, and that the official bond filed by the said Jack Naud is hereby approved by this Board. All members voting in the affirmative the chairman declared the motion carried.

A motion was made by F. M. Wooden and seconded by Ira Short that the report submitted by Ed O, Cassidy, Special Deputy State Examiner and Inspector, be and the same is hereby approved and accepted, which report is as follows:

Gentlemen:

I am herewith submitting for your consideration a report as to the condition and progress of the work directed by you to be performed by the State Examiner and Inspector's office, as of this date.

L. The Report of the audit of T.N. Griffith, Justice of the Peace, District No. 11, Sand Springs has been approved by the Department and an official copy filed with the Governor and an official copy filed with the County Clerk to be submitted to you for your approval and actionthereon; also a form of a resolution has been prepared and accompanies the report directing the county attorney to proceed and enforce the report by proper legal proceedings.

- 2. On the 13th inst., we collected the sum of \$1363.00 from the Oklahoma Union Railway Company, the same representing an overpayment made to it by former Court Clerk B. F. Ingraham. A part of this amount will be paid to the City of Tulsa in settlement of a balance due it in a case wherein the city was plaintiff and due from Ingraham.
- 3. The typing of the Porter, Court Clerk audit is progressing rapidly. the Superior Court civil cases is completed and the District Court Civil cases as well as the Probate cases County Court are fifty percent completed. The typing of the report the of these courts is/heavier part of the work. The Broken Arrow Division of the County Court will be audited as soon as the audit of the Justice of the Peace J.T. Thompson is completed.
- 4. The auditing of the records of Justice of the Peace J.T. Thompson is now in progress. We were delayed three days in this work caused by the assembling of his records. His criminal docket has been audited on the General Detail and we are now auditing the receipts and disbursements as shown by his docket records. This cash audit is nearly completed. In addition to the general detail and the cash audit, there will be five more schedules to prepare before closing this audit.

No unforseen delay occurring we will have this audit completed this week and the approved report in your hands at your next meeting.
