ORDER FIXING TIME AND PLACE OF HEARING.

Now on this 2nd day of August, 1943, the Board of County Commissioners of Tulsa County, being in regular session, convened, all members including the County Clerk of said County being present and participating. Thereupon come W. O. Dickenson, C. J. Rush and Robt. G. Fry, the viewers heretofore, on March 15th, 1943, duly appointed by said Board of Commissioners, and filed herein their written certified reports as such viewers, under the petition and amended petition, heretofore filed herein with the County Clerk by Jessee Tabor and others praying for the creation of a certain Drainage and Improvement District in Tulsa County as set out and described in said petition and viewers report, both of which is hereby made a part hereof as fully as if copied herein. ✓

It is therefore ordered by said Board of Commissioners of said County, that August 30th, 1943, at 10:00 o'clock A.M., at the regular meeting place of said Board at the Courthouse in Tulsa, Oklahoma, be and the same is hereby fixed as the time and place for a hearing of said petition and amendment of Jessee Tabor and others for the creation of said Drainage and Improvement District in said County and as described in said petition and viewers report.

And, also, at the same time and place for a hearing on the report of the viewers as filed thereon and it is Ordered that notice of such hearing be given by publication in The Sand Springs Leader, a legal publication, for four successive weeks, and as required by law.
