The following Resolution was introduced by Commissioner Greer, who moved its
adoption; said motion being seconded by Commissioner Kinkaid. Chairman ordered the resolution

R E S O L U T I O N

RESOLVED, that a ration bank account or accounts, as defined in General Ration
Order #3, be opened and maintained in the name of Tulsa County Highway Department, with the National
Bank of Tulsa, Tulsa, Oklahoma, which bank shall act as an agency of and under the direction and
supervision of the Office of Price Administration, and shall be responsible only to the Office of
Price Administration; that the following officers or employees of the Tulsa County Highway Department:

Geo. O. Straughan, County Engineer or
W. K. Gray, Chief Clerk

are hereby authorized on behalf of the Tulsa County Highway Department, and in its name (said Tulsa
County Highway Department being a department of Tulsa County government and under the supervision
and control of the Board of County Commissioners of Tulsa County, Oklahoma) to sign ration checks
as defined in said order; to endorse ration books or other ration evidences owned or held by Tulsa
County Highway Department, for deposit in said account; and

FURTHER RESOLVED, that a certified copy of this Resolution be forwarded to said
bank and the Office of Price Administration; and

FURTHER RESOLVED, that the National Bank of Tulsa, Tulsa, Oklahoma, be and it is
hereby authorized to receive and honor all ration checks signed by Geo. O. Straughan, County
Engineer of Tulsa County, Oklahoma, or W. K. Gray, Chief Clerk; and

FURTHER RESOLVED that the foregoing resolution shall remain in full force and
effect until written notice of an amendment or rescission shall have been received by said bank; and

FURTHER RESOLVED that the foregoing authorization and resolution shall apply
to any and all ration bank accounts which the Tulsa County Highway Department is or may at any
future time be required or authorized by the Office of Price Administration to open or maintain
without further authorization from this Board; and

FURTHER RESOLVED that Andy Stokes, County Clerk of Tulsa County, Oklahoma, be
and he is hereby authorized and directed to certify to said National Bank of Tulsa, Tulsa, Oklahoma,
and to the Office of Price Administration, this resolution.
