

MONDAY, JUNE 18, 1945

The Board of County Commissioners met in regular session on Monday, June 18th, 1945 at the hour of 10:00 o'clock A. M., with the following members present: J. B. Gray and Robert L. Kinkaid, Members. Andy Stokes, County Clerk. Curtis Greer, Chairman, absent.

Motion made by Commissioner Gray, seconded by Commissioner Kinkaid, that Commissioner Kinkaid act as Chairman in the absence of Curtis Greer, Chairman. Motion carried.

Robert L. Kinkaid, Commissioner, Acting-Chairman presiding, the following business was transacted.

Motion made by Commissioner Gray, seconded by Commissioner Kinkaid, that the report filed by Emile F. Sterger, Clerk of Common Pleas Court for the month of May, 1945, be and the same is hereby accepted and filed. Upon roll call, both members voting in the affirmative, motion was by the Acting-Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Kinkaid, that the claim (No. 367550) filed by H. E. Bridges in the amount of \$321.00 covering easement for Section Line right-of-way of the North 40' of the Northwest Quarter of the Northwest Quarter, and the North 40' of the West half of the Northeast Quarter of the Northwest Quarter of Section 35, Township 20 North, Range 13 East, Tulsa County, containing 1.07 acres, more or less, be and the same is hereby approved, and the County Clerk instructed to issue warrant to cover. Upon roll call, both members voting in the affirmative, motion was by the Acting-Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Kinkaid, that the following affidavits of erroneous assessments filed and approved by Dan A. Rowe, County Assessor be and the same are hereby approved, and the County Clerk is hereby instructed to issue Certificates of Error covering same, to-wit:
