The Board of County Commissioners of Tulsa County, Oklahoma, met in regular recessed session in the County Courthouse of Tulsa, Oklahoma, on the 10th day of June, 1938, at ten o'clock A.M., with Commissioners John H. Miller, J. B. Gray, Harry L. Hopkins and County Clerk Andy Stokes present.

John H. Miller acted as Chairman. It was brought to the attention of the Board that pursuant to resolution passed by this Board of County Commissioners at a special meeting held on the 25th day of May, 1938, notice was given by the County Clerk that complaints and objections to the apportionments and appraisements made by the Board of Appraisers duly appointed by this Board, which report was filed on the 25th day of May, 1938, would be heard on June 10th, 1938; and that by error the World Publishing Company failed to publish said notice in the several issues as instructed and new notice and new hearing is required to be had.

Thereupon it was moved by Gray, seconded by Hopkins, that the said resolution authorizing the hearing of complaints and objections to the appraisal and apportionments made and filed on May 25, 1938, be withdrawn, vacated, rescinded and cancelled. The vote on said motion was: Miller, Aye; Gray, Aye; Hopkins, Aye. Motion carried.

Upon motion duly made by Gray and seconded by Hopkins, resolution setting date for hearing complaints or objections to the appraisal and apportionment which was filed by the Board of Appraisers on May 25, 1938, was passed. The following vote was had: Miller, Aye; Gray, Aye; Hopkins, Aye. Motion carried.

R E S O L U T I O N

WHEREAS, the Board of Appraisers heretofore on the 25th day of May, 1938, appointed by this Board of County Commissioners of Tulsa County, Oklahoma, have filed their report and return on the appraisal and apportionment of the benefits by the construction of the public distribution system of Water Improvement District No. 9 of Tulsa County, Oklahoma, against certain tracts, lots and parcels of land situated therein;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA, that a session of said Board of County Commissioners of Tulsa County, Oklahoma, be held at ten o'clock A.M. on the 1st day of July, 1938, at their office in the County Courthouse in Tulsa, Oklahoma, for the purpose of hearing complaint or objection that may be made concerning said appraisal.

Notice of said session and hearing shall be published by the County Clerk for two weeks in the Tulsa Daily World, printed in Tulsa County, Oklahoma, and of general circulation in Tulsa County, Oklahoma, and in said Water Improvement District.
