

authorize the contractor to make an addition to the structure under the original Contract?

Your attention is especially directed to Article 9 of the original contract, which refers to the original Architects drawings and specifications, and provided that "IT IS UNDERSTOOD THAT ALTERATIONS MAYBE MADE IN THE WORK AND ADDITIONS THERETO OR REDUCTIONS THEREFROM BY THE BOARD AT ANY TIME", which language confers upon the Board of County Commissioners authority to make such additions to the original contract without the formality of readvertising or resorting to any statute for such authority as the authority is retained by the Commissioners in the contract, and every bidder had notice of that condition which was embraced in the plans and specifications that he, she or it had an opportunity to examine, and familiarize themselves before submitting their bid.

It is the opinion of the County Attorney of Tulsa County that the Board of County Commissioners in their discretion may contract with the contractors to make such alterations changes, additions or deductions as in their judgment will inure to the benefit of the County on said contract, job or work, and pay for the same or receive credit as the case may be without vitiating or limiting the terms and conditions of the original contract.

MEMORANDUM OF AGREEMENT FOR EXTENSION WORK  
BETWEEN TULSA COUNTY AND THE EXTENSION DIV-  
ISION OF THE OKLAHOMA AGRICULTURAL AND  
MECHANICAL COLLEGE CO-OPERATING WITH THE  
UNITED STATES DEPARTMENT OF AGRICULTURE.

**OBJECT:** For the purpose of assisting farmers and farm families of Tulsa County with the many problems of farming, home making and community life, the Extension Division Of the Oklahoma Agricultural and Mechanical College and the Board of County Commissioners of said County, acting under authority of law, enter into this contract for carrying on co-operative demonstration work in agriculture and home economics, including 4-H club work in Tulsa County during the year beginning July 1st. 1931 and ending June 30th. 1932.

**METHOD OF PROCEDURE** For the objects expressed above, the Oklahoma Agricultural and Mechanical College, co-operating with the United States Department of Agriculture shall select the agent or agents to be employed, such persons to be well qualified to fill these positions by training, education and experience, who shall be satisfactory to the Commissioners of said County.

The County Commissioners agree to pay Two Hundred Twenty Five Dollars (\$225.00) per month on the salary of a County Agricultural Agent, and One Hundred Twenty Dollars (\$120.00) per month on the salary of a County Home Demonstration Agent for a period of Twelve (12) months, beginning July 1st. 1931. The County Commissioners further agree to furnish an office and to appropriate the following amounts to apply on the expenses of the County Agent \$2,000.00; for the County Home Demonstration Agent \$1,000.00; for Office Assistant to County Agent \$1920. The expenses to be paid monthly and the total amount paid in one month not to exceed the proportionate part of the year the agent has worked.
