WHEREAS, said Board of Commissioners have not yet definitely decided upon any person or agency, and have not yet determined the most feasible plan for the disbursement of the charitable funds of said County;

NOW, THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of the County ofmTulsa:

FIRST: That the Board of County Commissioners do not immediately determine upon or establish any mediate or fixed plan for the disbursement of such funds, but that only temporary arrangements be made for usuch purposes, until this Board shall be persuaded that a certain definite plan for the best interests of the public should be adopted and put into operation;

SECOND: BE IT FURTHER RESOLVED, That this Board invite the Board of Directors of the Tulsa Community Fund to meet with this Board with the object in view of holding the necessary conferences or meetings and to do all things necessary to arrive at and determine upon the most feasible and practicable plan for the disbursement of the charitable funds of said County during said fiscal year.

THIRD: mBE IT FURTHER RESOLVED, That a copy of this Resolution be furnished to the President of the Tulsa C mmunity Fund, and that he be requested to call a meeting of the Board of Directors of said Community Fund at as early a date as possible, for the purposes hereinabove indicated.

## RESOLUTTION

All claims for services rendered under this Contract shall be presented to the Board of County Commissioners for allowance.
