On recommendation of the County Attorney's Office, moved by Commissioner Bailey, seconded by Commissioner Caffey, and upon roll call unanimously carried, that the following Resolution be, and the same is hereby adopted:

R E S O L U T I O N

WHEREAS, the County Attorney in Case No. 14,567 Criminal, in the District Court of Tulsa County, Oklahoma, on the 10th day of April, 1951, forfeited the appearance bond of defendant, Jack Hayes, and C. E. Wells and Helen Chalert, sureties; and

WHEREAS, suit was instituted in the District Court of Tulsa County, Oklahoma, for recovery on said bond in the amount of \$1,000.00, being case No. 82,109; and

WHEREAS, the sureties on said bond have offered to compromise and settle said matter for the sum of \$666.66, plus \$5.00 accrued court costs, and the County Attorney has recommended said settlement;
