Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 1:30 O'clock P. M. with the following members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. William P. Gable, Jr., County Clerk.

J. B. Gray, Chairman, presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that upon the recommendation of the County Attorney, the following Resolution is hereby approved. Upon Roll Call, all members voting in the affirmative, motion was by the Chairman declared carried:

R E S O L U T I O N

This matter comes on to be heard before the Board of County Commissioners of Tulsa County, Oklahoma on this 3 day of July, 1947, upon the application of Elmer W. Adams, County Attorney, Tulsa County, Oklahoma requesting permission and authorization of this Board to compromise and settle the case of the State of Oklahoma Ex rel Elmer W. Adams plaintiff, vs George Perry, Chris G. Garvis and Alvin W. Perry defendants, case number 75151 District Court of Tulsa County, Oklahoma and the Board being fully advised in the premises finds,

That heretofore on the 22nd day of November, 1946, in the case of the State of Oklahoma vs George Perry, being case number 12687 District Court, Tulsa County, Oklahoma, charge being rape, and on said date above styled case was set for trial, that the defendant George Perry left the jurisdiction of this Court of the District Court Tulsa County, Oklahoma during said trial and thereafter bond in the sum of \$5,000.00 was forfeited and suit immediately filed against the above named principal and sureties, that thereafter judgment was entered against the principal and sureties in the sum of \$5,000.00, that in due course the property of the sureties was levied upon, advertised and sold, that a controversy arose between the sureties as to the method and procedure of sale, that Chris G. Garvis and Alvin Perry, the sureties, has offered to compromise and settle the above styled case for the sum of \$3,500, the Board further finds that the sum of \$3,500.00 is fair equitable and just and should be accepted and the County Attorney authorized to enter into such settlement,

THEREFORE, BE IT RESOLVED BY the Board of County Commissioners of Tulsa County, Oklahoma that Elmer W. Adams, County Attorney of Tulsa County, Oklahoma is hereby authorized and empowered to compromise and settle case number 75151, State of Oklahoma Ex rel Elmer W. Adams County Attorney, plaintiff, vs George Perry et al defendants, for the sum of \$3,500.00 in full settlement of the above styled case, that upon receipt of said \$3,500.00 to pay into the District Court of Tulsa County, Oklahoma \$2,625.00 and to retain for the use and benefit of Elmer W. Adams, County Attorney, the sum of \$875.00 being a sum equal to 25 per cent of the settlement as is provided by Law.
