PETITION

Comes now Public Service Company of Oklahoma, a corporation, and hereby shows to the Board of County Commissioners of Tulsa Ounty, Oklahoma, that it furnishes electric light and power to the Citizens of Tulsa and Vicinity, all in Tulsa County, Oklahoma, and a said Public Service Company of Oklahoma desires to build, equip, establish and maintain a pole line on the public highway commencing at a point $\frac{1}{4}$ mile East of the Southwest Corner of Section 28, Townshup 19, North, Range 12 East, and 22' North of South line of said Section 28, and extend West to a point 22' North of South Line and 22' West of East Line of Section 29. Township 19 North, Range 12 East, then 22' West of the East Line of Section 32, Township 19 North, Range 12 East for a distance of approximately 2000' to a point 22' West of East line of Section 32, Township 19 North Range 12 E and 27' South of the center line of paved highway, known as Sapulpa Road. Then Southwest 27' South of and parallel with center line of said highway for a distance of approximately 2 miles to the point where said Highway crosses the Tulsa-Creek County line. Also, beginning at a point 22' North of South Line of Section 28, Township 19 North Range 12 East and 13' West of center line of paved highway known as Sapulpa Road and extend Southwest parallel with center line of said highway for a distance of approximately 3000 to a point 22' West of East line of Section 32, Township 19 North, Range 12 East, and 13' West of center line od said Highway. All situated in Tulsa County, State of Oklahoma, in accordance with attached map, for the purpose of conducting electric current over the same for furnishing current to prospective customers, and
