Upon motion of F. M. Wooden seconded by Ira Short, the report of Ed O. Cassidy, Special Deputy State Examiner and Inspector, was filed with, accepted, and approved by the Board of County Commissioners, said report being as follows, to wit:

I am herewith reporting to you on condition and progress of Audit services assigned to State Examiner and Inspector by you from time to time. This report covers the period since date of last report, to wit: December 19", 1921, and up to and including this date.

Porter Audit:

The audit of John D. Porter County Clerk, has been completed excepting the Broken Arrow, Division of the County Court and a very small amount of work remains to by done on this division. The Broken Arrow Division of the County Court would have been completed on December 31st, 1921, had it not been for the fact that at your request we suspended this work in order to begin worn on Emergency Audits of the Justice of the Peace. All of the Porter Audit has been type-written, except the Broken Arrow Division, and the comparing of the type-written report will begin on January 4th, 1922, We contemplate being able to file with you at your January 16",1922; Session the approved report.

J.T. THOMPSON. JUSTICE OF THE PEACE.

The regular audit of J. T. Thompson, Justice of the Peace, District No. 4 City of Tulsa, has been approved as by law required and an official copy submitted to you today for your consideration.

The audit of searches and seizures of the same Justice of the Peace is is completed and we are today submitting to you a preliminary report.

S. R. HALLMAN, JUSTICE OF THE PEACE.

The audit of the records and files of S. R. Hallman, Justice of the Peace is now in progress. In order to expedite this work as well as the completion of the search and seizure audit of Justice Thompson at your request, we suspend all audit work in progress, at the close of business Friday, December 30", 1921, and begun the audit of searches and seizures, Justice Thompson, and the general audit of the records and files of Justice Hallman on Saturday December 31st, 1921, working our force on Sunday and Monday (Legal Holidays) in order to rush these audits to an early completion and report, we expect to be able to submit a completed report on the Hallman Audit on Saturday January 7th, 1922. In the Event, that we are ready to report at a time earlier than the date herein fixed you will be notified in order that you may convene on the day we are ready to submit our report. In asmuch as this audit effects a number of persons and will have much to do in your consideration of other serious matters, we are endeavoring to safe guard this audit with all the care and circumspection possible.

In the Hallman audit our original plan contemplated the auditing of searches and seizures first and reporting thereon, but matters coming to our attention before beginning the work and connected with our regular audit, caused us tore-arrange our plans and begin a complete audit.

In addition to a suspension of the John D. Porter Audit we have as requested by you delayed the preparing of the financial statement, general fund, as of December 31, 1921, and application for Supplemental appropriations, same fund, We planned to begin this work on January 3rd, 1922.

In the matter of the settlement made by the Board with T. N. Griffith,

Justice of the Peace, the amount of \$178.26, has not at this date been paid nor no part thereof,
