## AGREEMENT

THIS AGREEMENT entered into this 20th. day of July, 1931, by and between The Board of County Commissioners of Tulsa County, Oklahoma, and the duly appointed and constituted Committee of the Community Fund of The Cityof Tulsa, Oklahoma, said Committee being composed of Mrs. SamMcBirney; Mrs. Emil Solomon and Miss Velma McWilliams.

WITNESSETH: That the said parties hereto agree to and do hereby constitute themselves a joint Board to be known as The County Welfare Department of Tulsa County, the purpose of said joint Board being to carry on outdoor relief within the City limits of Tulsa until such time as appropriations for the fiscal year 1931-32 for Tulsa County, Oklahoma, shall have been made and approved by the Excise Board and until such time as by mutual arrangement of said parties the purposes and objects of said joint Board shall have been provided for through other agencies.

Said Board of County Commissioners of Tulsa County, in consideration of the services of said Community Fund Committee, and for the purpose of providing temporary relief until such time as the Excise Board of Tulsa County shall have made and approved appropriations therefor, agrees as a temporary set-up for the time said Joint Board may be in operation to allow claims and issue warrants in payment thereof not to exceed an aggregate amount of \$4,000.00 per month, for the purposes ordinarily and customarily incurred for poor and sick relief purposes by said Tulsa County and by law authorized, as same may be approved by HAROLD M VAUGHN, the Chief Executive of said Joint Board.

It is further agreed by the said Board of County Commissioners, that it will employ four Welfare Workers, or Assistants, and will provide the use of three (3) automobiles, the salaries and operation, the same to be provided for out of the \$4,000.00 per month above named, the said cars so provided to be used by the Welfare workers designated by the Chief Executive of said Joint Board.

It is further understood and agreed by and between said parties, that said Community Fund Committee shall furnish its organization, for the purposes above named, and that in particular shall provide and pay for from its own funds, for the services of said Chief Executive; that said Chief Executive shall have full authority to transact all necessary business for and on behalf of said Joint Board, and that he is hereby designated as the legal representative of said Tulsa County for the purposes hereinabove set forth, and that in his absence Mrs. Emil Solomon, Chairman of the Council of Social Agencies shall have authority.

It is further understood and agreed by and between said parties that said joint Board operating as the County Welfare Department, may secure and purchase, for the purpose of its welfare work only, gasoline from the County Garage, at suchmprice as the said gasoline may cost the County, the same to be paid for out of the \$4,000.00 per month above stated.
