TO THE EXCISE BOARD OF TULSA COUNTY, OKLAHOMA.

Gentlemen:

In pursuance of the provisions of Section 12680, Oklahoma Statutes of 1931, as amended by Article 18, Session Laws of 1937, application is hereby made for additional and supplemental appropriations with which to meet the legal and ordinary expenses of Tulsa County, Oklahoma, for the remainder of the fiscal year ending June 30th, 1938.

In support thereof, we do hereby certify:

First: That certain appropriations heretofore made are inadequate to properly maintain the General Fund of Tulsa County, Oklahoma, for the current fiscal year, and that the public welfare and needs of said County are such as to require for the remainder of said year, for legal and ordinary expenses, the additional appropriations as listed and set forth by purposes and amounts in Exhibit "A" attached, and made a part hereof, and in the total amount of \$16,389.21.

Second: That the financial statement hereto attached and marked Exhibit "B" shows as of the close of business June 20th, 1938, the true and correct condition of the General Fund of said municipality, and the surplus of \$11,398.80 thereon shown is available for additional appropriations.

Third: That the appropriations listed in Exhibit "C" hereof aggregating \$7,851.19 are for purposes less urgent and imperative than the additional needs herein requested.
