Whereas, it is desired and deemed necessary to secure right of way for Roads and Highways,, and to improve the Roads and Highways in Skiatook Township Tulsa County Oklahoma, by Draining, grading, gravelling or macadamizing the same, the estimated cost of which is \$20,000.00; and

Whereas, due authority is granted by the Constitution and Laws of the State of Oklahoma, for the issuance of bonds by townships for said purpose, and there being no funds in the treasury available for said purpose, and the said sum of \$20,000.00, together with all outstanding indebtedness of said township' is less than three per cent of the assessed valuation of taxable property in said township as fixed by the State Board of Equalization for the year 1915; Now Therefore:

BE IT RESOLVEDBY THE Board of County Commissioners of Tulsa County, Oklahoma in session for the transaction of business,

Section one

That a special election be and the same is hereby ordered to be held in Skiatook Township Tulsa County, Oklahoma, on the 22 day of January, 1916 for the purpose of submitting to the qualified electors of said township the following proposition:

Proposition

Shall the Board of County Commissioners, Tulsa County Oklahoma, acting for and on behalf of Skiatook Township in said County, be authorized to issue the negotiable coupon bonds of Skiatook Township, Tulsa County, Oklahoma, in the amount of \$20,000.00 for the purpose of providing funds for the purpose of Securing right-of-way and for the Improvement of Roads and Highways in said Township by Draining, Grading, Gravelling or Macadamizing same, and levy and collect an annual tax upon all the taxable property in said Township, in addition to all other taxes, for the purpose of paying the interest on said bonds when due, and also constitute a sinking fund for the payment of the principal thereof when due; said bonds to bear interest at the rate of Six per cent per annum payable semi annually, and to become due \$10,000.00 in ten years; \$5000.00 in fifteen years, and \$5000.00 in twenty years from their date.

Section Two

That a proclamation and notice of said election shall be and the same is hereby authorized and ordered to be given; same to be signed by the Chairman of the Board of County Commissioners, and attested by the County Clerk of said County under seal of said County, and shall set forth the proposition to be voted upon; the date of the election; the hours of opening and closing of the polls; the number and location of the voting places and the regular precinct officials shall conduct said election, which proclamation and notice shall be posted in at least ten places within said Township for at least thirty days prior to the date fixed for said election. Returns of said election shall be made and the results canvassed as in such cases provided by law.

Section Three

That this resolution shall be in full force and effect immediately from and after its adoption and approval.

ADOPTED AND APPROVED THIS 20th day of December, 1915.

After the resolution was read in full, a motion was made by A. W. Lucas and seconded by Cyrus S. Avery, that the same be adopted as read. Motion carried, and resolution adopted.
