PROPOSITION.

Shall the Board of County Commissioners of Tulsa County, Oklahoma acting for and on behalf of Skiatook Township in said County, be authorized to issue the negotiable coupons bonds of Skiatook Township, Tulsa County, Oklahoma, in the amount of \$20000.00 for the purpose of providing funds for the purpose of securing Right-of-way and for the improvement of Roads and Highways in said Township by Draining, Graiding, Gravelling or Macadamizing same, and levy and collect an annual tax upon all the taxable property in said Township, in addition to all other taxes, for the purpose of paying the interest on said bonds when due, and also constitute a sinking fund for the payment of the principal thereof when due said bonds to bear interest at the rate of Six per cent per annum payable semi annually and to become due \$10000.00 in ten years; \$5000.00 in fifteen years, and \$5000.00 in twenty years from their date.
