## RESOLUTION

FOR THE CROSSING AND MAINTAINING OF A LEVEE OVER A 36" WATER LINE OWNED AND OPERATED BY THE OKLAHOMA POWER AND WATER COMPANY IN THE NW 1/4 OF THE SW 1/4 OF SECTION 19-TOWNSHIP 19 N-RANGE 12 E., TULSA COUNTY.

WHEREAS, Tulsa County, Oklahoma, by and through its Board of County Commissioners has requested permission to construct a levee across the 36-inch water line of the Oklahoma Power and Water Company in the Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4) of Section Nineteen (19), Township Nineteen (19) North, Range Twelve (12) East, Tulsa County, Oklahoma.

AND WHEREAS, the Oklahoma Power and Water Company has indicated that it will grant, without charge, permission to the said Tulsa County; Oklahoma, to construct said levee across said water line at point aforesaid upon certain conditions contained in its letter addressed to this Board under date of September 16th, 1936, which said letter reads as follows:

AND WHEREAS, Mr. W. E. Davis, County Engineer, has talked to us regarding the proposed construction of the levee on the South side of the Arkansas River. The proposed route of this levee will cross our 36-inch water line in the Northwest Quarter (NW 1/4) of the Southwest Quarter (SW 1/4) of Section Nineteen (19), Township Nineteen (19) North, Range Twelve (12) East. Our water line was installed in this location by a right of way grant from Mr. A. F. Ault, as recorded in Book 863, Page 598, Tulsa County.

AND WHEREAS, it is our desire to cooperate with the County in the construction of this levee, however, it is necessary that we see that no harm is done to our water line or to customers served over this line. We are willing for the levee to be constructed on the proposed site under the following conditions:

- 1 That the levee not be raised more than 36 fnches above the normal surface level of the ground in this vicinity.
- 2 That no borrow pits will be made, or earth removed between our water line and the river in the Northwest Quarter (NW4) of the Southwest Quarter (SW4) of Section Nineteen (19), Township Nineteen (19) North, Range Twelve (12) East, or
