Pursuant to adjournment, the Board of County Commissioners met in the office of the County Clerk with all members present: J S Shaver, Chairman, W L North and Ed W. Hedgecock, Members. Mr. Shaver presiding, the following business was transacted: The claim of L W Lisher in the amount of \$5,480.00 was ordered allowed and warrant issued to cover.

Motion was made by Mr. North, seconded by Mr. Shaver, that it is the judgment of this Board that the objection to the jurisdiction of this Board to proceed further with the hearing of the appeal in the matter of the annexation of School District No. 46, to District No. 23, be sustained for the reason that in the judgment of the Board of County Commissioners twenty five per cent (25%) of the qualified voters of the District have not been represented in the appeal from the County Superintendent to this Board. Upon roll call, the following vote was cast: Shaver, Yes, North Yes, Hedgecock, No.

Comes now the Petitioners and excepts and objects to the ruling of the Board and moves the Board to allow the Petitioners until Monday, October 11th. 1926, at the hour of five o'clock P M time in which to file an amended notice of appeal signed by twenty five (25%) of the qualified electors of the School District No. 46. Upon motion of W L North, seconded by Mr. Shaver, the Board does hereby grant the time, as requested. All members voting in the affirmative, the motion is declared unanimously carried.

Motion was made by Mr. North, seconded by Mr. Hedgecock, that GLENN ELLIOTT be and he is hereby appointed Member of the Tulsa County Highway Patrol. Motion carried.
