#### R E S O L U T I O N

AUTHORIZING CONVEYANCE TO YADON INVESTMENT COMPANY OF THE NORTH 25' OF LOT 40 AND SOUTH 25' of LOT 31, LESS THE EAST 25' OF EACH TRACT THEREOF IN AERIAL HEIGHTS SECOND ADDITION, A SUBDIVISION OF THE SE $\frac{1}{4}$  OF THE NE $\frac{1}{4}$  AND SW $\frac{1}{4}$  OF THE NE $\frac{1}{4}$  OF THE NE $\frac{1}{4}$  OF SECTION 26, TOWNSHIP 20 NORTH, RANGE 13 EAST, TULSA COUNTY, OKLAHOMA.

WHEREAS, heretofore, under date of June 2, 1928, Yadon Investment Company, a corporation, did by warranty deed convey to Tulsa County, Oklahoma, a conveyance of land for roadway purposes and did by inadvertence include therein the strips of land hereinafter described which should not have been so conveyed, and

WHEREAS, by resolution of this Board on September 26, 1936, the dedication of said strips of land so inadvertently described was vacated, and

WHEREAS, the said grantor in said deed has requested a conveyance of said strips to the said grantor;
